

## CONFIDENTIALITY DECLARATION

### ARTICLE 1 - PERSONAL INFORMATION COLLECTED

When you make a purchase on our shop, as part of our purchasing process and sales, we collect the personal information you provide to us, such as your name, address and e-mail address.

When you browse our shop, we also automatically receive the address internet protocol (IP address) of your computer, which allows us to get more details about the browser and the operating system you are using.

Email Marketing (if applicable): With your permission, we may send you e-mails about our shop, new products and other updates.

### ARTICLE 2 - CONSENT

How do you get my consent?

When you provide us with your personal information to complete a transaction, place an order, schedule a delivery or return a purchase, we assume that you consent to us collecting your information and using it for this end only.

If we ask you to provide us with your personal information for another reason, for marketing purposes for example, we will ask you directly for your consent explicit, or we will give you the opportunity to decline.

**How can I withdraw my consent?**

## ARTICLE 7 - SERVICES PROVIDED BY THIRD PARTIES
